  - July 2021 anyone eligible

### **Outreach Plan**



Survey and Focus Groups

Disability Rights California California



- Diverse voices
- Incentives to participate
- Mailed to Regional Center clients
- Distributed through federal partners' networks



### Focus Group Accessibility

- Offered on Zoom in the evening
- Live Spanish translation
- Questions designed to be non-leading and balanced
- All materials reviewed by people with developmental disabilities



### Focus Group Interest

### 9 focus groups

- Enrolled participants
- Not enrolled regional center clients
- Family members of enrolled participants
- Family members of not enrolled regional centers clients
- Independent facilitators
- Enthusiastic response over 1500 people signed up
- Created "qualitative survey" to hear more voices
- Survey translated into 10+ languages




### **Program Evaluation Phases**

*N* = 604






### Participant Diagnosis and Age



**Developmental Disabilities** 



# What We Learned about California's Self-Determination Program

# Important Findings: Overall

- Support for the Concept of SDP (P2, P3)
  - Many agreed with the idea that people with disabilities should have more freedom to design and pursue their life paths, with supports of their choosing
  - The concept inspired hope, and people want the program to succeed

### • SDP Furthers the Principles of Self-Determination (P1, P2, P3)

- SDP enhances participants' quality of life
- SDP furthers freedom, authority, support, responsibility, confirmation in a variety of ways



## Important Findings: Overall

### • Participants Endorse the SDP (P1, P2, P3)

- A majority were satisfied and would recommend the program
- Grateful to be in the Self-Determination Program; find it "life-changing"
- Believed it was the right choice for them

"With Self-Determination I have more freedom to choose who helps me get things done. My staff is now someone I trust and not a stranger... I love that I have a spending plan that I can see and understand."

"SDP has been life-altering... My son makes all of the decisions in his life now. He receives social support in a natural environment doing the things he loves. He has support taking a college course at the local junior college. He is working with supported employment and has had a paid internship at his favorite comic bookstore. He travels independently to hang out with friends.

"My services [in SDP] better meet my needs than the vendors through the traditional model... SDP has improved my quality of life. I'm receiving the in home and community support I need."

# Important Findings: Overall

- Participants Wish SDP was Easier, with More Support (P2, P3)
  - Need to reduce the administrative burden, complexity, and demands on participant's time
  - Call for enhanced supports for participants and families through information availability, staff training, and capacity



"I really wish it was more of a one stop shop where you could get your services started and finalized in one agency. Having so many agencies and choices and decisions to make is confusing to myself and has made it difficult moving forward. I think removing a lot of the complications involved with selfdetermination would be helpful. I've been trying for over 2 years to finalize my enrollment."

"Parents are already overwhelmed... It is a lot to deal with all the steps to get the services and to chase down paperwork, spending plans, signatures and people... Simplify this process even more, somehow, some way."

# Important Findings: Overall

- Inequities Exist in the SDP (P1, P2, P3)
  - Participants described inequities on the basis of race, Regional Center, disability, socioeconomic/education, native language, and urban/city (P2, P3)
  - Less Support, Lower Satisfaction, yet Higher Positive Outcomes for BIPOC Participants (P1, P3)
  - SDP is Harder to Navigate for Younger Participants (P1, P3)
  - SDP is Harder to Navigate for Autistic Participants (P1, P3)




"[I am a] highly educated professional with an MA, able to reduce my work hours so I can keep this SDP going, and I am having a very hard time... How is this ever going to be accessible for non-native English speakers, [those] who can't afford to work less, [those] who may not have much support?"

Most SDP participants expressed some level of positive agreement with the statement:

I am pleased with my overall experience in Self-Determination Program.






Most SDP participants would recommend the Self-Determination **Program through** endorsement of the statement:

I would recommend the Self-Determination Program.


**Somewhat** Agree, 20.1%



### **New Directives Following the Report**

DDS has issued **25 new directives for the SDP** since July 1, 2023

Many are related to report recommendations:

- Financial Management Services (FMS)
- Billing requirements
- Reporting requirements on SDP from regional centers
- Expanded clarification on goods and services
- Clarification on payments for trained supports to get enrolled



### Proposed Legislative Action SB 1281 (Menjivar)

- SB 1281 introduced 2/15/24
  - Senator Caroline Menjivar (D San Fernando Valley)
- Purpose: Equity and Access in SDP
  - Streamlining processes
  - Support choice for services
  - Improve transition support
  - Improve Financial Management Services (FMS)
- Outcome: Bill vetoed by Governor
  - DDS Master Plan

# Master Plan for Developmental Services – SDP Points

- Improve Access to Information & Clarify Roles
- Streamline Enrollment
- Reduce Administrative Burden / Simplify Spending Plans
- FMS Enhancements (accountability, labor laws, timely payments)
- Promote Equity & Inclusion Diversity of Participants
- Enhance Orientations
- Ensure Person-Centeredness All Services



## **Moving Forward**

- Continued Advocacy
  - Make it easier for participants and families to understand and access
  - Streamlining processes across the state
- Data Needs
  - Comparison of outcomes in SDP vs. Traditional Services
  - Differences in barriers by demographic group, including differences for BIPOC, younger, and Autistic participants
- Future considerations
  - Gather perspectives from regional center service coordinators
