AUCD, 2024

LEND: Leadership Education in Neurodevelopmental and Related Disabilities

- Who: 60 programs in 44 states/territories. 4 in CA (UC-LEND, CHLA, UC Davis, UC San Diego/SDSU)
- Funding: Autism CARES Act
- Administration: Maternal Child Health Bureau (MCHB)
- Role: Interdisciplinary graduate-level training to clinicians, researchers, and community leaders on neurodevelopmental disabilities to improve care and outcomes across the lifespan



IDDRC: Intellectual and Developmental Disabilities Research Center

- Who: 15 programs. 2 in CA (UCLA, UC-Davis)
- Funding: National Institute of Child Health and Human Development (NICHD)
- Role: Conduct research into the causes of intellectual/developmental disabilities. Evaluate the effectiveness of interventions. Training opportunities for researchers



UCEDD: University Centers for Excellence in Developmental Disabilities

- Who: 68 programs in every state/territory. 3 in CA (UCLA, UC-Davis, USC-CHLA).
- **Funding:** Authorized under DD Act
- Administration: Administration on Intellectual and Developmental Disabilities (AIDD)
- **Role:** Respond to state and local needs of people with disabilities through research, service, and education. Work to transform policies and systems. Member of the developmental disabilities (DD) network.

UCEDD Core Functions


- **Research and Evaluation:** Researching and adding to the latest findings and policies.
- Information Dissemination: Providing useful information and resources
- Interdisciplinary Training: Training to professionals across disciplines
- Community Service: Understanding community training and technical assistance needs












Developmental Disabilities (DD) Network



AUCD, 2024

State Council on Developmental Disabilities (SCDD)

- **31** members appointed by the Governor
- Members include individuals with disabilities, their families, federally funded partners and state agencies
- 5 year state plan
- Yearly work plan created by SCDD
- Yearly report to federal government



SCDD, 2024

Disability Rights California (DRC)

- 24 offices in CA with over 340 staff
- Protects and advocates for the rights of people with disabilities
- Advocacy through legislative action
- Legal aid services
- Training and outreach

Personal Advocacy

- Speak on your own opinions
- Use your own email
- Use your own phone
- Use your own time
- Do not reference your employer





Professional Advocacy

Advocating/Educating

- Educate about what we know
- Educate about our experiences
- Cannot ask for specific bills/laws

Lobbying

- Ask for specific bills/laws
- Done by registered (and paid) lobbyists
- Represent
 organizations/interests



5 W's of Communicating with Legislators: Who

- Know who your legislators are
- Look it up!
- Both state and federal representatives
- Staff



5 W's of Communicating with Legislators: What

- Know the message you want to give
- Use resources from organizations
- Search for bills on state and federal websites (end in .gov).



5 W's of Communicating with Legislators: Where

- State capitol
- Washington D.C.
- Virtually
- Community Events
- Local offices



5 W's of Communicating with Legislators: When

- Timing is everything
- Too soon and it's not on their radar
- Too late and it's too late




5 W's of Communicating with Legislators: How

- In person
- Virtually
- Email
- Phone call
- Use your time effectively!

- UC Leadership Academy for Emerging Disability Rights Leaders
- 10 week virtual program
- Teaches advocacy skills
- TEL Your Story model



<u>TEL Your Story:</u> <u>Trustworthiness</u>

- Build credibility
- Describe who we are
- What are my qualifications?
- Why am I an expert?



TEL Your Story: Emotion

- Stories vs. numbers
- Talk about experiences
- Why does it matter to me?
- What is my story?



TEL Your Story: Logic

- Back up your story
- Do your research
- Who does this impact?
- Do facts support my opinion?
