A. Personal Statement

As a mid-level research scientist, I have been conducting cutting-edge quality HIV biobehavioral research since 1999. In addition to my training in cross cultural psychiatry, I have completed a 2-year National Institute of Mental Health (NIMH)-funded Post Doctoral Fellowship and was in the first cohort of trainees for the Centers for Disease Control and Prevention (CDC) Minority AIDS Research Initiative (MARI) training program. I have also participated in the National Institutes of Health (NIH) African American Mental Health Research Scientists (AAMHRS) training program. Through these opportunities, I have been able to increase my knowledge and hone my research skills in culturally congruent biobehavioral HIV interventions for diverse populations including African American and Latino men who have sex with men (MSM), African American women, and mental health disparities. As an HIV interventionist, my research focuses on understanding psychological and socio-cultural factors that affect positive behavior change, including historical barriers and trauma histories among ethnic and sexual minorities. I have been mentored and have collaborated with senior intervention experts, working on large multi-site studies such as the four-city NIMH-funded Eban project for African American sero-discordant couples and the HIV Prevention Trials Network (HPTN) 061, a community-level, multi-component feasibility intervention study for black MSM. My independent research has included developing and testing the Men's Health Project, an HIV risk reduction intervention for HIV-positive Black and Latino MSM, and my current two interventions for Black MSM entitled, Men of African American Legacy Empowering Self (MAALES) and the Enhanced Sexual Health Intervention for Men (ES-HIM). MAALES focuses on HIV risk reduction among Black bisexual men, while ES-HIM focuses on a vulnerable population by examining biological markers of stress among HIV-positive bisexual men with histories of childhood sexual abuse and intimate partner violence. Additionally, I am mentoring a young investigator who received a diversity supplement to my parent grant to develop and HIV risk reduction intervention for monolingual Spanish speaking Latino MSM. I have also examined substance abuse and trauma histories among African American and Latina women and have developed the Females of African American Legacy Empowering Self (FemAALES) intervention for African American women with HIV at-risk male partners. I am extremely well trained in correlates of health disparities, theoretical models of behavioral change, curriculum development and process evaluation measures.
